As per Government Order read as 2nd paper above, Government have accorded sanction for the delegation of powers to the departmental officers for according technical sanction, inviting tenders, award of work, execution of agreement, etc. in respect of normal public works being implemented by the Department of Soil Survey and Soil Conservation.

- 2) As per the letters read as 4th and 5th papers above, the Director has requested to Government to modify/extend delegation in the following manner:
 - 1. Delegate financial powers for Inviting Tenders, Award of Work and Execution of Agreement to Join Director for ₹50-200 lakh.
 - 2. Modify delegation of financial powers for Inviting Tenders, Award of Work and Execution of Agreement of Additional Director for ₹ 100-300 lakh.
 - 3. Delegate powers to record Soil and Water Conservation works in the M-Book to Overseers with 3 years of Experience in Government and having Diploma/B Tech in Civil/Agriculture Engineering.
 - 4. Enhance powers of the Committee comprising Director as Chairman with

Additional Director and Executive Engineer (Civil) from Minor Irrigation/LSGD as members for issuing Technical Sanction with no upper limits.

- 5. Extending delegation of financial powers for Issuing Technical Sanction and also for Inviting Tenders for Award of work and execution of Agreement to the officers of the Soil Survey wing of the Department.
- 3) The Empowered Committee for delegation of financial powers, in the meeting held on 08.12.2022 considered the above proposal in detail and after careful consideration, decided to accept the proposal.
- 4) In the circumstances, Government are pleased to delegate/modify financial powers delegated to the subordinate officers of the Department of Soil Survey & Soil Conservation as detailed in the Annexure to this Government Order.
- 5) The Government Order read as 2nd paper above stands modified to the above extent.
